

## OFF Licence

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act  
2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), FERGUSSON LIQUOR LIMITED (the licensee) is authorised to sell alcohol on the premises situated at Unit 1, 1098 Fergusson Drive, Upper Hutt and known as Super Liquor Fergusson, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with subpart 7 of Part 2 of the Act.

### Conditions

This licence is subject to the following conditions:

- (a) No alcohol is to be sold or delivered from the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00pm on Anzac Day.
- (b) Alcohol may be sold only on the following days and during the following hours:  
**Monday to Sunday 9.00am to 10.00pm**
- (c) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed. The licensee or manager must ensure that:
  - i. alcohol is not sold to intoxicated persons,
  - ii. statutory restrictions on the supply of alcohol to minors are observed at all times and evidence of age documents are requested where necessary.
  - iii. signs clearly stating the above requirements be placed at all points of sale.
- (d) Drinking water is to be freely available to customers, while alcohol is being supplied free as a sample on the premises.
- (e) The whole of the premises is designated as a supervised area.

### DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S


A copy of this licence must be displayed in the interior of the premises so as to be easily read by persons using the premises. The entrance from the carpark Unit 1, 1098 Fergusson Drive is designated as the principal entrance.

### Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force.

- (a) either
  - i. until the close of the period for which it was last renewed; or
  - ii. if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either-
  - i. until the close of the period of three years after the period for which it was last renewed; or
  - ii. if it has been renewed, until the close of the period of four years after the day it was issued.
